



This is a Contract between ALL AMERICAN PET RESORTS PUNTA GORDA and the pet owner whose signature appears below (hereinafter called "Owner")

The overnight Boarding suites is \$53 per dog per night *PLUS ANY ADDITIONAL SERVICES ADDED.*

The day of drop off is always charged in full.

The day of pick up is \$20.00 additional per pet between 12:00 PM - 6:00 PM

Camera View Suites \$60 or VIP Suites \$70

The Daycare rate is \$35.00 per dog

LATE PICK UPS: Between 6pm-11pm Must be prearranged with a credit card on file and will be charged at an additional \$20 PER PET

Holiday Reservations require a Non-Refundable \$50 per pet Deposit/Non-transferrable

Items left with your pet may not be returned. If returned, they may be in poor condition. We are not responsible for those items left or their condition. Should any items left with your pet require cleaning, charges for laundering will be applied per item. We provide extra bedding upon request.

AGGRESSIVE PETS: Pets determined to be aggressive or otherwise difficult will be charged an additional handling fee of \$15.00 per day. Should your dog injure a staff member, customer or another dog, you will be held liable and responsible for any costs incurred. If we are unable to handle your pet(s) we reserve the right to request that you make alternate care arrangements for your pet immediately.

GROUP PLAY: Included with Daycare & Boarding. Should you desire that your pet participate in group play, please refer to the Group Play contract for details. Otherwise, all Private Times are \$15 each (15 minutes). Group Play is included in the Boarding rate.

BATHS & NAILS: Upon request your pet may receive a bath or a nail trim. Baths start at \$20 / Nails \$20

GROOMING: Owner understands that pet grooming services may require the use of scissors, clippers and other tools that may cause injury to Owner's dog. Owner authorizes use of these tools. Owner understands that circumstances may exist with Owner's dog, such as coat condition, sensitivity or pet behavior, that may make grooming difficult or impossible. Owner understands that a muzzle might be used, at the groomer's discretion, to help prevent any potential bites while grooming. Owner further acknowledges possible risks of grooming and agrees to hold AAPR-PG, its owners, managers, groomers and staff harmless and will not pursue legal action against them in the event of any injury to Owner's dog. AAPR-PG requires 48 hours' notice of cancellation of grooming services. After three cancellations under this requirement, Owner will be charged the full cost of grooming service. The final price of the groom is determined by the groomer based on the dog's behavior and coat condition.

COMMON CANINE MALADIES: I am aware that wherever multiple dogs come in contact with one another, my dog may be exposed to common airborne canine viruses, allergens and digestive upset. I am also aware that vaccinating my pet only protects my pet from known strains of viruses. This pet resort cannot control airborne viruses and allergens. I am aware that if my pet becomes ill while boarding, the staff will contact me. If my pet becomes ill once returning home, I agree to let the pet resort know as soon as possible. We do not cover the cost if treatment should your pup contract Bordetella.

INTESTINAL UPSET: We HIGHLY recommend that you provide your own food for your pet. We offer PURINA EN if you do not bring your own food. If you do not provide your own diet and your pet experiences an intestinal tract upset that results in the need for veterinary care all fees and expenses will be charged to you at check out. This includes intestinal upset due to a change in environment, stress and anxiety.

DESTRUCTIVE BEHAVIOR/EXTRA CLEAN UP FEES: In the event that your pet destroys any of our furnishings you will be asked to cover replacement costs, not to exceed \$100. Extra clean up due to excessive accidents will result in an additional \$10 fee per day.

INFESTATION: Pets entering this resort must be free of fleas and ticks. If your pet enters our resort with fleas or ticks, you will be assessed an infestation fee of \$50. Additional fees may also apply such as personal handling of your pet to remove fleas or ticks, the application of prevention products, Capstar and any other measures that must be taken by the resort in order to stop an infestation.

ABANDONMENT: State statutes consider pets to be abandoned if not picked up by the owner(s) after 10 days following the arranged pick up date. Abandoned pets will either become the property of the local animal shelter or adopted without resort liability.

HURRICANE SEASON: Our resort is located in Evacuation Flood Zone "A". We require an emergency contact person to pick up your pets up in case of a mandatory evacuation. No pets or staff will be in the building after evacuation. You cannot board your pet without an ER contact during this season (June 1st - November 30th).

PHOTO & VIDEO RELEASE: Owner consents and grants permission to AAPR-PG to use my likeness in any photograph, video or other digital media. I agree that AAPR-PG owns the images and all rights to them and that AAPR-PG can use them in any and all of its publications, advertising or promotional material including print, video, digital or web-based publications. I hereby grant All American Pet Resorts Punta Gorda permission to obtain vet information regarding my pet's vaccinations and overall health history and any needed veterinary treatment for my pet at my expense.

I have read this agreement and understand its terms and conditions. I further entrust All American Pet Resort Punta Gorda to care for my pet(s) for current and future boarding.
