DOG BOARDING & DOGGIE DAYCARE AGREEMENT, POLICIES & RELEASE OF LIABILITY

MEDICAL ATTENTION. Owner (also “I”, “My” or “Me”) understands that Luther Family Pet Boarding, LLC d/b/a All American Pet Resorts - Shelby Twp. (hereinafter “AAPRST”) is not a veterinary establishment and does not practice veterinary medicine. I understand and agree that if my dog(s) become ill or injured, of if the state of the dog’s health requires medical attention, AAPRST., IN ITS SOLE DISCRETION, MAY ENGAGE THE SERVICES OF A VETERINARIAN AND/OR ADMINISTER MEDICINE OR GIVE OTHER REQUISITE ATTENTION TO THE DOG OR IF SHOTS ARE EXPIRED, AND I CONSENT TO SUCH TREATMENT AND THE EXPENSES SHALL BE PAID BY OWNER. AAPRST staff will make their best efforts to notify Owner in the event of a serious illness or injury using the contact information provided to AAPRST. Owner understands that Owner is responsible for providing updated contact information. Owner agrees to assume full financial responsibility for any and all expenses incurred by AAPRST to attain medical attention to my dog from AND I AUTHORIZE AAPRST OR ITS EMPLOYEES THE USE OF MY CREDIT CARD FOR SUCH PURPOSE. Owner releases and its staff from any and all responsibility for, or claims, damages, debts, arising out of or related to such medical care, including, but not limited to, transportation to/from the veterinary clinic and choice of veterinarian and animal hospital.

PHOTO & VIDEO RELEASE: I agree to allow AAPRST. to use my pet’s name and any images or videos taken while he/she is in the care of AAPRST., in any form or format, for use, at any time, in any media, marketing, advertising, illustration, trade or promotional materials and that AAPRST is the exclusive owner of any images or videos containing the pet.

DOG’S HEALTH: Owner understands and agrees that Owner’s dog(s) are healthy and have current vaccinations for rabies, parvo, distemper and Bordetella. Owner agrees not to enroll any dog that has any condition that could potentially jeopardize the health of other dogs or people and that the dog has not had any potentially communicable condition within 30 days prior to enrollment. Owner further understands that even if Owner(s) dog is vaccinated for Bordetella (Canine Cough) there is a chance that the Owner’s dog can still contract Canine Cough. OWNER AGREES THAT AAPRST IS NOT LIABLE OR RESPONSIBLE IF OWNER’S DOG(S) CONTRACTS CANINE COUGH OR OTHER DOG-TO-DOG TRANSMITTED AILMENTS.

CANINE COUGH:

_____ I understand that Canine Cough is a highly contagious upper respiratory viral infection that is primarily passed from one dog to another through direct contact but also passes through aerosol droplets in the air.

_____ I understand that there are many different strains of Canine Cough some of which are not covered by vaccines.

_____ I understand my dog/s are at risk of contracting Canine Cough when bringing them into any type of Social environment where other dogs are or have been recently including but not limited to Vet’s Office’s Boarding Facilities.

_____ I understand that older dogs and puppies have a higher risk of contracting Canine Cough.

_____ I understand if my dog/s contacts Canine Cough I will notify All American Pet Resorts - Shelby Twp. and will not bring my dog back to daycare until they are fully clear of any symptoms.

_____ I understand that if my dog/s contract Canine Cough that AAPRST will not be responsible for vet bills or other associated costs.

WEAKENED IMMUNE SYSTEM: Owner understands special-needs dogs, young puppies, and senior dogs naturally have a higher risk of injury, stress-related illnesses, weakened immune system, or exacerbation of any pre-existing condition. AS SUCH, BY USING OUR FACILITY FOR DAYCARE OR BOARDING THE OWNER IS WAIVING ANY CLAIM FOR INJURY OR ILLNESS EXPERIENCED BY OWNER’S DOG WHILE IN OUR CARE.

GROUP PLAY: Owner understands and agrees that in admitting Owner’s dog(s) to dog-dog group play, Owner is representing to AAPRST. that Owner’s dog(s) is/are in good health and have not harmed, shown aggression, or exhibited any threatening behavior towards any person or other dogs. Dogs may be dismissed at the sole discretion of AAPRST from group play for behavioral, medical, or age-related reasons. Dogs must be altered prior to one year of age in order to participate in group play. If not altered, dog will be placed in private play. IF DISMISSED/UNALTERED, THE DOG WILL BE A ‘PRIVATE PLAY’ DOG AND OWNER WILL BE RESPONSIBLE FOR THE ADDITIONAL \$15 PER DAY FEE.

RELEASE OF LIABILITY: DURING THE TIME THAT THE PET IS IN THE CUSTODY OF AAPRST, AAPRST SHALL NOT BE LIABLE FOR ANY SICKNESS, DISEASE, DEATH OR INJURY WHICH MAY BE SUFFERED BY THE PET OR ANY OTHER CAUSE OF ACTION, WHATSOEVER,

ARISING OUT OF OR BEING CONNECTED IN ANY WAY WITH THE BOARDING/CARE OF SAID PET. Safety is our #1 priority. Owner understands and agrees that during normal dog play, Owner's dog may sustain injuries. Dog play is monitored by All American Pet Resorts – Shelby Twp. staff to best avoid injury, however during play scratches, accidental puncture, or torn ligaments, and other injuries may occur despite the best supervision.

FOOD & FEEDING: AAPRST provides a premium diet for all dogs. Because changing diet can upset a dog's stomach, you are welcome to bring your dog's own food in individually portioned Ziploc bags. A bagging fee of \$5 per day will be applied to those guests without proportioned food. In addition, our resort does not accept any bowls or measuring utensils from home. If AAPRST's food is provided, AAPRST is not responsible for any food allergies or complications that may occur.

PERSONAL ITEMS: Do not bring items with your dog(s) that are valuable or irreplaceable. Owner agrees that AAPRST shall not be responsible or liable for any lost, stolen, or damaged personal property belonging either to my dog or Owner. Owner also understands and agrees that the dog's collar and flea collar will be removed in the play area to prevent injury.

MEDICATIONS / SUPPLEMENTS: If your dog is on medication and/or vitamin supplements, please bring more than enough of each for your dogs entire stays in the original containers, should we need to supply these items in the event they are exhausted. Insulin administration by our trained staff is available for a charge of \$10/day per pet. Non-injectable medication administration by our trained staff is available for a charge of \$5/day per pet. AAPRST IS NOT LIABLE FOR ADMINISTRATION OF MEDICATION.

GROOMING: When boarding, complimentary baths are given to guests staying seven or more nights. During high boarding times, complimentary baths will not be offered, however baths may be purchased at a discounted rate.

PAYMENT: Prices are posted and subject to change. All charges incurred for the pets stay shall be payable upon pick up of the pet. AAPRST, at its discretion, may require a deposit or for Owner to pay charges at time of check-in. AAPRST is hereby granted a lien on the pet for any and all unpaid charges resulting from the pets stay. Charges begin on Owner leaves the pet. For prepaid packages, Owner understands that prepaid daycare packages are nonrefundable and expire 12 months from date of purchase. For extended boarding stays, a credit card must be on file and Owner consents to and will be charged weekly. Should Owner be unable to pick up pet in person, then a representative of Owner must provide proof of identity along with a call from Owner and payment will need to be received by AAPRST before pet can be released. Owner agrees to be responsible for all costs of collection of unpaid charges, including attorney fees.

CLOSING TIME: Owner agrees that if Owner's dog(s) is/are not picked up by closing time, then Owner hereby authorizes overnight boarding for the dog(s) and to pay AAPRST for applicable overnight boarding charge(s).

RESERVATIONS. If a reservation is made, a valid credit card number is required to hold your reservation. During non-holidays, cancellations must be provided at least 48 hours before check-in date or a \$50.00 fee will be owed and charged to the credit card on file. During holiday/peak periods, a seven (7) day minimum notice of cancellation before the check-in date must be provided or a \$100 fee will be owed and charged to the credit card on file.

RIGHT OF REFUSAL: AAPRST reserves the right to refuse admittance to any dog or dismiss any dog that does not meet our daycare/boarding standards. The determination shall be made at the sole discretion of AAPRST.

ABANDONMENT: If you fail to pick up dog by the designated time and fail to make satisfactory arrangements with AAPRST, then after ten (10) days, your pet will deemed to be abandoned and AAPRST will deliver the pet to a third party adoption agency, Animal Control or another government agency and Owner will lose ownership of the pet. Charges continue to accrue and Owner will remain liable for all unpaid charges. Abandoned pets become the property of AAPRST and Owner releases AAPRST from any liability or further responsibility for the pet
